## Note:

- 1. Dual registration should be requested at the current department **before** semester starts. (Students must formalize this intent by the start of the semester.) Only with the approval of the faculty advisor or tutor, chair, dean, and the Registrar may the applicant be dually registered.
- 2. Graduate and PhD students who have yet to choose their thesis advisor should ask the chair to sign the advisor's column.
- 3. Credits earned in other institutions may be waivered before being dually registered according to *Directions for Credit Waiver for NKNU Students*. Credits earned in other institutions may *not* be waivered if students enrolled in NKNU first then dual registered in other schools, or if students dual registered from the start. Students enrolled in two ore more departments in NKNU may waiver their earned credits based on directions mentioned earlier. Students enrolled in degree programs in different schools that reqire a thesis should produce two theses different in topic and content. If a student obtained their degrees through theses of similar nature, we will revoke the degree granted by our school, whereas a student enrolled in two or more departments in our school will have one of their degrees revoked.
